This alloy offers good fluidity and joint strength and is used to braze copper, brass, steel, stainless steel and some nickel alloys. The silver deposit color is a good match on stainless steel. It's excellent fluidity promotes braze penetration. Close tolerances are recommended; 0.002-0.005" for best performance..
